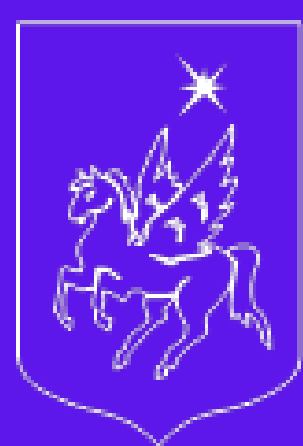

ENTRY REQUIREMENTS

Applicants with an education of the appropriate level, confirmed by a document on secondary general education or a document on vocational secondary education and qualifications, or a document on higher professional education, confirmed by the assignment of the qualification are allowed to master the educational program.

APPLICATION

Application for acceptance of documents for enrolment (by mail).

Consent to the processing of personal data of the applicant.

Identity document, citizenship.

Documents confirming the individual achievements of the applicant.

An agreement on the provision of paid educational services (for admission on a contractual basis).

PROGRAM STRUCTURE

The first year of study implies acquisition of fundamental knowledge, mastering general humanitarian, socio-economic subjects (logic, economics, and law enforcement, theory of state and law, history of state and law.

The second year focuses on the study of fundamental subjects (criminal law, administrative law, civil law, criminal procedure law, etc.).

The third and fourth years are aimed at continuation of basic and profound study of specialized subjects. At the end of the third year, students undertake an internship in the profile of professional activity. In the fourth year, there is an internship to acquire professional skills and experience in professional activities.

The fifth year focuses on the following core subjects: participation of the prosecutor in civil and arbitration proceedings and administrative court proceedings;

Prosecutorial oversight of respect for human and civil rights and freedoms; organization of crime investigations, etc.

CAREER OPPORTUNITIES

Graduates may carry out their professional activities in the courts of general jurisdiction, the procuratorial authorities, the Investigative Committee, the Ministry of Internal Affairs, the Federal Security Service and other law enforcement agencies and legal departments of various organisations.
